THE GOVERNOR'S MESSAGE

Like all the communications from our able Executive, the message is pertinent and to the point. It is likewise of commendable length, and deals directly with the most important subjects of State legislation without entering into those discussions and irrelevant details upon national policy.

The message begins by impressing upon the representative of the people of Louisiana the necessity of complying with the injunctions of the constitution in regard to a new apportionment of the State. Every attempt has for many successive terms utterly failed to make an effort to establish on a just basis the system of representation.

The condition of the State treasury is precarious. The expenditures exceed the annual income \$190,000, and the deficit in 1912 will probably reach \$300,000. Under these circumstances retrenchment and economy are required on the one hand, and increased taxation on the other.

The banks generally are considered in a better condition for meeting their payments now than they were when they resumed in 1910. The obligation under these institutions lies in maintaining their credit, and this is regarded as a chief duty of the Legislature.

Additional penal provisions against frauds on banks are recommended, particularly against those who obtain money by drawing checks on banks which have no funds. Several cases of this kind have occasioned large losses to these institutions.
