When the act was passed there was but one General Land Office, situated at New Orleans. Since that time a branch Land Office has been established at Winnsboro, La. The confusion of jurisdiction has already taken place between the two offices, which has been settled by the Supreme Court against the office at Winnsboro. A piece of land located by a warrant to the office at Winnsboro, and which was sold by private entry, is reported to have been sold by the office at New Orleans. It is respectfully recommended that the act be amended so as to give to the office at New Orleans the jurisdiction over all lands located by warrant to the office at New Orleans, and to the office at Winnsboro the jurisdiction over all lands located by warrant to the office at Winnsboro.
