

CHARTER

ARTICLE PREMIER. That the name and title of the Corporation hereby formed is declared to be "Henderson Bartholot Co. Limited."

ARTICLE SECOND. That the objects and purposes for which this Corporation is established and the nature of the business to be carried on by it, are hereby declared to be buying, selling and dealing in Oil and Tobacco; to buy, sell, lease, sub-lease, or otherwise dispose of, or to hold, any real or personal estate, that may be necessary to its business.

ARTICLE THIRD. That the Capital Stock of this Corporation is hereby fixed at the sum of Fifty Thousand Dollars (\$50,000) divided into or represented by Five hundred (500) shares of the par value of One hundred dollars (\$100) each, to be paid for at such time and in such installments as may be determined by the Board of Directors.

ARTICLE FOURTH. That this Corporation, through its Board of Directors shall have the power and authority to contract, sue and be sued in its corporate name, to make and use a seal, to hold, receive, hire or purchase real or personal property, and to sell, mortgage and pledge same, to borrow money on its own bonds, to issue and deposit its own notes, and to do all other things which a corporation may lawfully do.

ARTICLE FIFTH. That all the corporate powers of this Corporation shall be vested in and exercised by a Board of three Directors, who shall own at least one share of the capital stock of the Company; the majority of whom shall constitute a quorum for the transaction of all business.

ARTICLE SIXTH. That the first Board of Directors of said Corporation shall consist of Messrs W. W. Wallis, George A. Henderson and C. I. Wallis, with the said W. W. Wallis, President and George A. Henderson as Vice-President and Secretary.
