UNITED STATES OF AMERICA, STATE OF LOUISIANA, PARISH OF ORLEANS, CITY OF NEW ORLEANS.

BE IT KNOWN, That on this twenty-third day of the month of July, in the year of our Lord, one thousand nine hundred and...

Article I. The name and title of the corporation hereinafter formed shall be the COLIMBIA RAILWAY AND LIGHT COMPANY.

Article II. The domicile of the corporation shall be in the Parish of Orleans, Louisiana. All suits...

Article III. The objects and purposes for which this corporation is organized and the nature of the business...

Article IV. The capital stock of this corporation is hereby fixed at thirty thousand dollars (\$30,000.00)...

Article V. All the corporate powers and authority of this corporation shall be vested in a President and Manager, a Vice-President, a Secretary and Treasurer...

Article VI. All the shares of the capital stock of this corporation shall be held in the name of the Corporation...

Article VII. Both the stockholders and the corporation shall be bound by the terms of this charter...

Article VIII. The stockholder shall ever be held liable or responsible for the debts of the corporation...

Article IX. At the termination of this charter by limit of time or otherwise the business affairs of the corporation shall be liquidated...

Article X. This charter shall be signed by the undersigned and shall be filed in the office of the Secretary of State...
