CHARTER

STATE OF LOUISIANA PARISH OF ORLEANS CITY OF NEW ORLEANS

BE IT KNOWN, That on this Fifth day of October, in the year of our Lord, One thousand nine hundred and six, and of the independence of the United States of America, the one hundred and thirty first...

ARTICLE I. The name of this corporation shall be the CONSUMERS LUMBER MANUFACTURING AND EXPORT COMPANY and under the corporate name it shall have...

ARTICLE II. The domicile of this corporation shall be in the City of New Orleans and the State of Louisiana and all citation or legal process...

ARTICLE III. The objects and purposes for which this corporation is organized and established and the nature of the business to be carried on by it are hereby declared to be to buy, build, maintain and operate...

ARTICLE IV. The capital stock of said corporation is hereby fixed at the sum of Fifty thousand dollars (\$50,000) divided into five hundred (500) shares...

ARTICLE V. All the corporate powers of said corporation shall be vested in and exercised by a Board of Directors to be composed of three stockholders to be elected annually on the 5th day of October...

ARTICLE VI. Whenever this corporation may be dissolved either by the act of God or from any other cause, its affairs shall be liquidated by two commissioners to be appointed amongst the stockholders...

ARTICLE VII. This act of incorporation may be modified, changed, altered or amended in any particular by a majority vote of three-fourths of the capital stock...

ARTICLE VIII. No stockholder shall ever be held liable for the contracts or debts of said corporation in any further sum than the unpaid balance due the corporation on the shares of stock owned by him...

ARTICLE IX. D. A. Hackney, R. H. Hackney, and William J. Young have been chosen and selected as the first Board of Directors of this corporation with R. H. Hackney, as President, D. A. Hackney, as Secretary and Treasurer, to act until the 5th day of October 1907...
