CHARTER

STATE OF LOUISIANA PARISH OF ORLEANS, CITY OF NEW ORLEANS. BE IT KNOWN, That on this Fifth day of October, in the year of our Lord, One thousand nine hundred and six, and of the Independence of the State of America, the one hundred and thirty first...

ARTICLE IV. The capital stock of this corporation shall be the CONSUMERS LUMBER MANUFACTURING AND EXPORT COMPANY, and under its said corporate name it shall have power and authority to have and enjoy corporate existence for the full term and period of ninety-nine years, from and after the date hereof, to-wit: the first day of January, 1907, and until the expiration of the said term and period...

ARTICLE V. All the corporate powers of said corporation shall be vested in and exercised by a Board of Directors to be composed of not less than five nor more than fifteen stockholders, the number for each year to be fixed by resolution of the Board...
