ARTICLE I. The name and title of the corporation here formed is declared to be the JOHN A. LAMPSON LIMITED under which it shall have and enjoy corporate success...

ARTICLE II. The domicile of this corporation shall be in the City of New Orleans, Louisiana. All contracts and other legal process shall be served on the President of the Company...

ARTICLE III. The objects and purposes for which this corporation is organized and the nature of the business to be carried on by it are hereby declared to be carrying on of a general grocery and commission business...

ARTICLE IV. The capital stock of this corporation is hereby fixed at the sum of one hundred thousand dollars (\$100,000) divided into one hundred shares...

ARTICLE V. The corporate powers and authority of this corporation shall be vested in a President and Treasurer and two Directors who shall constitute a Board of Directors...

ARTICLE VI. All elections shall be by ballot and held at the office of said corporation at the residence of the President...

ARTICLE VII. Each of the stockholders subscribing to this charter shall agree to transfer to the corporation the right of purchase of such shares...

ARTICLE VIII. No stockholder shall ever be held liable for the contracts or debts of this corporation in any way...

ARTICLE IX. At the termination of this charter by limitation or otherwise the business and affairs of the corporation shall be liquidated by three commissioners to be appointed from among the stockholders...
