

CHARTER.

UNITED STATES OF AMERICA. PARISH OF ORLEANS. CITY OF NEW ORLEANS.

BE IT KNOWN that on this Fourteenth day of the month of October in the year of our Lord One thousand nine hundred and ten...

ARTICLE I. The name and title of the corporation hereby formed is to be the JOHN A. ALSINA COMPANY LIMITED under which name it shall have and enjoy corporate succession for the period of twenty years...

ARTICLE II. The domicile of this corporation shall be in the Parish of Orleans, Louisiana. A citation or other legal process shall be served on the President of the Company or if he is absent on the Vice President or Secretary and Treasurer.

ARTICLE III. The objects and purposes for which this corporation is organized and the nature of the business to be carried on by it are hereby declared to be the carrying on of a general retail grocery and commission business...

ARTICLE IV. The capital stock of this corporation is hereby fixed at the sum of twelve thousand dollars (\$12,000.00) divided into one hundred and twenty shares of One hundred Dollars each per value...

ARTICLE V. The corporate powers and authority of this corporation shall be vested in a President and Treasurer and two Directors, who shall constitute a Board of Directors...

ARTICLE VI. The stockholders shall be held and held liable for the contracts or debts of this corporation in any further sum with the unpaid shares owned by them...

ARTICLE VII. Both the stockholders subscribing to this charter and all future stockholders agree with each other not to dispose of their stock without first giving in writing to the other stockholders three days notice of such intended transfer...

ARTICLE VIII. No stockholder shall ever be held liable or responsible for the contracts or debts of this corporation in any further sum with the unpaid shares owned by him...

ARTICLE IX. At the termination of this charter by limitation or otherwise the business and affairs of the corporation shall be liquidated by three commissioners to be appointed from among the stockholders...
